3. Status DBM by Dannie Kjeldgaard

Slagelse plus cand merc HRM

Due to failed negotiations with RUC and not enough opportunities for growth in Campus Slagelse, SDU has decided to close Campus Slagelse. There will be no new intake of students in Slagelse and it will be closed down by 2027.

Dannie has started the process of individual conversations with affected colleagues in Slagelse to get a clear indication of what is desired and what opportunities the department has to offer. In January 2024 the opportunities will be investigated further and a framework agreement Slagelse employees will be negotiated.

When budget cuts were made in the spring, it was decided to close the HRM cand merc profile in Odense. However, since the agreement with RUC is cancelled, it has been decided to open for intake in the fall of 2024. DBM is to cover the profile in terms of research and education.

As there is a cap of student places, we are not allowed to just raise our own intake of students. But sometimes if other faculties have excess capacity we might be allowed to take in more students on our programmes. But it is a political decision and not up to us.

Department of Business and Sustainability - Jutland

The new name of the Business School department in Jutland includes Sustainability. We on DBM also have a lot of sustainability research and there is no monopoly of this in Jutland, so we can still carry on with our sustainability research.

Head of department Chrisian Elmelund-Præstekær has previously been Head of Department of Political Science and Public Management and recently come from Faaborg municipality. Kristin B. Munksgaard, Christian and Dannie constitute the management team of the Business School.

Strategy

Almost all groups have given their input to the DBM strategy.

The strategy will contain a brief strategy with action points and values and will be presented in the new year to the department.

Professional master area - status & process

Eva Riis, Jacob Lyngsie and Marianne H Frederiksen have spent the fall on a market research that will be presented to the management of the faculty later this month. The dean has a strong wish for a more international MBA and this and more will be elaborated on.

Financial Situation

The forecast is still that we will have a deficit in 2024, but in 2025 and 2026 things look slightly better right now.

Communication
