1. News from IST Restructuring at IST: From September 1, 2020, Clinical

Pharmacology & Pharmacy and Environmental Medicine function as a joint research unit with Kim Brøsen as head of research. The change is part of a generational change and to facilitate a better flow in the change of the management. In addition, it is more rational to combine the two laboratories into one function which is very important for the department to

secure.

The new structure offers an opportunity to create a broader academic environment as well as it maintains the visibility of

the units publicly.

In future, the unit will consist of tree research groups, each having their own group management: Pharmacology & Pharmacy headed by Kim Brøsen, Environmental Medicine headed by Tina Kold Jensen, and the laboratory headed by

Tore Bjerregaard Stage and Flemming Nielsen.

Office reshuffle WP 9: CPOP (former MaxO) employees move to offices at SAMF. Preliminary moving day is September 15, 2020.

2. News from SUND

NytSUND: The process of moving. Among other things, an ITcommittee has been appointed to ensure that the SDU and the OUH IT-systems operate together.

Biobanks SDU: At present working towards -80-degree freezers, but the operation of -190-degree freezers are even cheaper. IST cannot change everything into -190 degrees, but it is being investigated whether it is possible to work towards a change for future samples.

3. Working environment

Election to the working environment organization is in the autumn of 2020. Information about the process, the possibility to propose oneself as candidate etc. will be circulated when possible.

4. News from SDU and New holiday act: From September 1, 2020. Seems to work the IST secretariat fine. Heads of research agree that there is no need to change the process for approval and transfer of vacation days. Co-operation RIO: Agreement about a shorter processing

On several occasions, the finance assistant has not been informed of the collaboration, and collection of funds have therefore taken place too late. RIO does not ensure that the finance assistant is been informed.

<u>ERC Calls:</u> Deadline for applications will be circulated to the heads of research.

KB: He is glad to secure the laboratory and looks forward to an increased collaboration with Tina and Environmental Medicine. He looks forward to creating an even larger professional environment. Bettina Hansen has been employed from August 1, 2020 as study secretary after the retirement of Kirsten Anette Jensen.

BN: Quite reasonable return after the COVID lock down.

<u>LLF:</u> The unit is working a lot on establishing contacts and network, both national and international.

<u>DGH:</u> Several new employees will start in September, i.a. four new PhD-students. Three PhD-students turn in their theses this autumn. The analysis unit will get two new employees and one has found employment elsewhere.

<u>JBN</u>: Had hoped to be able to hold an academic event in combination with a Christmas staff party for all units, but at present the possibilities do not look good.
