# **News from IPH**

# Procedure regarding employment contracts from the Staff Office

All employment contracts must be in place before a new employee can begin the work. It often takes 2-3 weeks to process an employment contract - so be in time with the planning. IPH emphasises that all employees must have a contract before they begin working, or they must wait till it is signed.

IPH has had a few **Introductory Meetings** for new employees, but not many attended. The conclusion of the discussion with the heads of research is that they undertake the introduction of IPH to new employees. IPH prepare a PP with relevant topics and the head of research supplements with his own points.

The outcast for the University's overall Personnel Policy Guidelines was examined and commented. **English courses** should be a subject for the annual employee performance review.

## **Financial situation**

Twice a year the Dean invites IPH to a budget meeting. The next meeting is ultimo September. IPH is asked to bring an overall estimate of future external revenue. The external revenue forms part of incentive structure, and thus affects the annual frame from the Faculty. Therefore, the information is vital for IPH's budget.

## News from the management team at the Faculty of Health Sciences

The New University Hospital is expected to be delayed further - now till mid-2022. Perhaps the relocation of the Faculty will be accordingly postponed.

In future, all staff of the Health Sciences has to register their teaching portfolio. Further details will be forwarded in a separate mail.
