News from the Department of Public Health

An organization process on the research units CAST, Health Economics and User perspectives has been initiated. The aim is to strengthen the research and education capacity at the User Perspectives and to clarify the research of health economics and health economic evaluation. Employees from CAST will be transferred to User Perspectives and the remaining to Health Economics. CAST will then be abolished. The process will going on this spring/summer.

In connection with the organizational changes, Head of Research of User Perspectives Lotte Huniche has chosen to surrender the baton to Helle Johannessen. Instead of heading the unit, Lotte will be concentrating on large research projects. Although Lotte has taken part in initiating the organization changes, it will be Helle Johannessen who will be running the changes.

Jesper Bo expressed his thankfulness to Lotte for her efforts the past years as head of research. He was very grateful for her excellent input to a more multi-disciplinary perspective on the discussions at the head of research meetings.

The private institution Research Unit for General Practice had its license from Danmark Statistic revoked for 30 days. A procedure has now been developed to avoid similar situations. It was discussed whether it was reasonable to have one person responsible for all the licenses, if the Department's access can be revoked for 30 days. Danmarks Statistik demands that only one person is responsible. Perhaps it is possible to suggest a decline in one person's responsibility in relation to the number of approvals. Jesper Bo Nielsen has suggested the possibility of a software program that could stop too small amounts of data. Kaare Christensen suggests inviting Danmarks Statistik to inform the researchers about data features and possible risks.

News about finances

The financial year 2014 ended with a little loss of 3.3 million - slightly better than expected. The department is economically challenged. Therefore it has been decided to reduce the budget in 2015 as to various funds: the internationalization fund, the study account as well as the education account. The hiring of part-time scientific staff has been reduced by 25%, and the departments operating cost has been reduced by some 58%. With these cutbacks, it's not necessary to reduce the number of employees.
